No7/3/341(18287)-FS&CA/2019/ 19151 In exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with letter No. 11(9)/2014-ECR&E, dated 02.09.2014 of the Deputy Secretary, Government of India, Ministry of Consumer Affairs, Food and Public Distribution, New Delhi and in concurrence of the Removal of Licensing Requirements, Stock Limits and Movement Restrictions on Specified Foodstuffs (Fifth Amendment) Order, 2019 issued by the Government of India, Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs), vide notified Order S.O. 4417(E), dated 10.12.2019, the Administrator, Union Territory, Chandigarh is pleased to notify revised stock limits on Onion with immediate effect, till further orders. The stock limits on Onion in U.T., Chandigarh will be as given below:-

1. Stock of Onion:-

Sr. No	Type of Business	Stock Limit (All kinds)
1	Dealers- including Wholesalers, Distributing Agents, Selling Agents or such persons	25 MT
2	Retailers	2 MT


The order shall, however, not be applicable on Government agencies possessing above stated commodity on behalf of the Government. Any importer, being a wholesaler or retailer or dealer shall be exempted for the imported stock of onions.
